The subject E-Tender Notice, along with the advertisement and all bidding documents, was dispatched by this office on Friday, 10 July 2026 (**Enclosed**) On the same day, a copy was forwarded to the Managing Director, Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KP-PPRA) for uploading on the KP-PPRA website, and the tender was uploaded on the same date after receipt through email.

Similarly, a copy of the E-Tender Notice was sent to the Director General, Information and Public Relations Department for publication in various newspapers through Pakistan Post.

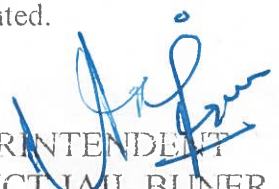
However, according to the available postal and departmental records. The E-Tender documents is delivered to Director, Information and Public Relations on 13 July 2026 but published on 17 July 2026 instead of the expected publication date in accordance with Rule 34(1). The delay occurred after dispatch from this office and was beyond the control of this office.

For verification, the postal/mail E-records of Buner, Mardan, and Peshawar are enclosed, which clearly show that the documents were handed over to Pakistan Post and delivered to DG information and public relation on 13 July 2026 without delay by this office. The available evidence indicates that the delay occurred on the part of DG information and public relation and not due to any negligence on the part of this office.

In view of the above facts and the enclosed documentary evidence, it is respectfully requested that this office may kindly be held to have complied with the relevant procurement rules and may not be considered in violation of Rule 34(1). The delay is attributable to the DG information public relation authorities after the documents had been duly dispatched.

It is, therefore, requested that the matter may kindly be considered sympathetically and the explanation submitted by this office may be accepted.

Your kind consideration in this regard may be highly appreciated.

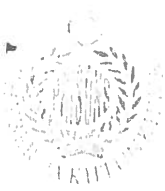
