Thank you for your letter regarding the Tender Notice for the Supply of Poultry Feed published in the Daily Mashriq on 27-06-2026 and your observations concerning Rule 34 of the Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules, 2014.

In this regard, it is submitted that this office had already taken corrective action by issuing a corrigendum vide Letter No. PRI/Est/49/592 dated 01-07-2026. Through the said corrigendum, the date for submission and opening of bids has been revised from 08-07-2026 to 22-07-2026.

The corrigendum was published in three national newspapers and was also uploaded on the EPAD portal to ensure wide publicity and compliance with the applicable procurement rules.

Accordingly, the revised schedule provides the required minimum fifteen (15) days' response time as prescribed under Rule 34 of the Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules, 2014. Therefore, the issue highlighted in your letter has already been rectified, and the procurement process is now fully compliant with the relevant rules.
