Subject: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules, 2014, Tehsil Municipal Officer, Tehsil Municipal Administration, Palas's Tender Notice for Procurement for Supply of Various Items

Dear Sir,

This is with reference to your tender notice appeared in Daily 'Mashriq' Newspaper on 29 April, 2026. The said advertisement is in violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules, 2014, Rule No. 34 'Response Time'.


In the tender notice, the submission and opening date of bid is given on 11-05-2026, where it does not fulfill the fifteen days of response time, and is two (02) days less. It is a violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules, 2014, Rule 34. The Rule is quoted below for your reference;

***34. Response time.**---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.*

Tehsil Municipal Officer, Tehsil Municipal Administration, Palas is requested to rectify the given mistake and issue corrigendum in accordance with Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules, 2014, to avoid mis-procurement under Rule 54.

Note:

This is to clarify that Transparency International Pakistan is not a complainant, it acts as a whistleblower and operate under Article 19-A, of the Constitution of Pakistan which gives the right to public to know how government is being run by public officers. Article 19-A makes the right to access of information pertaining to a public authority a fundamental right, and a three-member bench in case of Mukhtar Ahmad Ali vs the Registrar, Supreme Court of Pakistan, Islamabad, headed by Chief Justice Qazi Faez Isa in the landmark judgment on 16 October 2023, in CP No. 3532/2023, has declared that

“What previously may have been on a need-to-know basis Article 19A of the Constitution has transformed it to a right-to-know, and the Access to information is no longer a discretion granted through occasional benevolence, but is now a fundamental right available with every Pakistani which right may be invoked under Article 19A of the Constitution”

The E-bid must be submitted/uploaded through EPADS on or before 11/05/2026, till 1:30 pm. The technical bids on EPADS (e-bidding) shall be opened on the same day at 02:00 PM.
- The procuring entity shall evaluate the technical proposals in the manner as prescribed in the bid document and shall reject any proposal which doesn't conform to the specified requirements. The financial bids of technically accepted/responsive bids shall be opened publicly at the time, date and venue, which will be communicated to the bidder after technical evaluation through the provided email address.
- ORIGINAL two (2%) bid security of the total bid price in the shape of CDR in the name of "TMO TMA Palas" shall be sealed in envelope and marked as such and shall reach on below given address before the closing date and time.
- All applicable taxes including Sales tax, income tax, KPRA taxes, stamp duties etc. as per Government Rules enforced shall be applicable.
- All the rates shall be quoted on (FOR) basis with free supply/delivery to the TMA office.
- Successful bidder shall provide complete operational training to the staff.
- Incomplete, conditional, late submitted or manual bids shall not be entertained/accepted.
