**Subject: Violation of Punjab Procurement Rules 2014, Chief Officer, District Council, Toba Tek Singh's Tender Notice for Various Construction Works**

Dear Sir,

This is with reference to your tender notice appeared in daily 'Express' Newspaper on 29 November, 2025. The said advertisement is in violation of Punjab Procurement Rules 2014, Rule No. 14 'Response Time'.

In the tender notice, the submission and opening date of bid is given on 09-12-2025, where it does not fulfill the fifteen days of response time, and is four (4) days less. It is a violation of Punjab Procurement Rules 2014, Rule 14. The Rule is quoted below for your reference;

*14. Response time.— (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for prequalification) from the date of publication of an advertisement or notice keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.*

Chief Officer, District Council, Toba Tek Singh is requested to rectify the given mistake and issue corrigendum in accordance with Punjab Procurement Rules 2014 to avoid mis-procurement under Rule 69.

**Note:**

This is to clarify that Transparency International Pakistan is not a complainant, it acts as a whistleblower and operate under Article 19-A, of the Constitution of Pakistan which gives the right to public to know how government is being run by public officers. Article 19-A makes the right to access of information pertaining to a public authority a fundamental right, and a three member bench in case of Mukhtar Ahmad Ali vs the Registrar, Supreme Court of Pakistan, Islamabad, headed by Chief Justice Qazi Faez Isa in the landmark judgment on 16 October 2023, in CP No. 3532/2023, has declared that

“What previously may have been on a need-to-know basis Article 19A of the Constitution has transformed it to a right-to-know, and the Access to information is no longer a discretion granted through occasional benevolence, but is now a fundamental right available with every Pakistani which right may be invoked under Article 19A of the Constitution”

Bidders/contractors of the following Schemes of District Council, Toba Tek Singh are invited from engineering firms/contractors on the term stated as per PPRA E-Tendering system/E-bidding system, online with relevant PPRA Rules (amended/updated) and LOW Rules 2017, According to the Rules of the Firms/contractors can participate in tendering/bidding process with the following terms and conditions:-

- The intending Contractors/Firms/Bidders may participate who have been registered with Pakistan Engineering Council in the relevant category/codes.
- The intending Contractors/Firms/Bidders have to be registered on Punjab PPRA website ([www.punjab.eprocure.gov.pk](http://www.punjab.eprocure.gov.pk)). Any information/procedure regarding registration can be seen / obtained from website [ppra.punjab.gov.pk/e-procurement](http://ppra.punjab.gov.pk/e-procurement).
- Bid Documents are available on E-PAD System and PPRA Website also.
- The intending Contractors/Firms/Bidders have to attach/pledge the earnest money in the form of CDR in favour of Chief Officer, District Council, Toba Tek Singh @6% of the estimated/ bid cost and all rates against items of work on the same website upto half hour before the opening date and time of opening of tenders/bids. However, original CDR has to be submitted to the Opening Committee on the same day half hour before the opening of bids.
- After filing the bids on website, the intending Contractors/Firms/Bidders may attend the office of the District Council Toba Tek Singh on below given date and time where all bids will be retrieved and quoted rates/successful bidder will be announced in the presence of Opening Committee.
- In case of submission of any false information/document such as CDR/receipt, the Contractor/Firm will be disqualified from the current tendering process of District Council Toba Tek Singh. Further recommendations to PPRA and PEC will be made against such Contractors/Firms/Bidders for appropriate action/black listing.
- The Procuring Agency rejects all bids or proposals at any time prior to acceptance of a bid or proposal under PPRA Rule-35 with regard to rejection of bids.
- Recovery against credit of old material will be adjusted manually and accordingly bids will be evaluated.
- If the bidder quoted lowest rates are more than 5% of the estimated cost, the lowest bidder shall be bound to deposit additional Performance Security from the Schedule bank under the PLGW Rules and PPRA Rules.
- The Advertisement has been uploaded on PPRA web site on 22-11-2023 and EPADS on 22-11-2023 in which the date for receiving and opening of bids has been fixed as 09-12-2023.
