Subject: Violation of Punjab Procurement Rules 2014, Deputy Commissioner Multan, Kachehri Compound, Multan's Tender Notice for Procurement / Hiring of Services for Surveille Equipment / CCTV Cameras / Walkthrough Gates, Tentage / Catering & Food Items, Lighting/Generator and Transport during Upcoming Cricket Test Matches (Pakistan vs West Indies) to Be Held at Multan Cricket Stadium Multan from 13-01-2025 to 29-01-2025 During the Year 2024-25

Dear Sir.

This is with reference to your tender notice appeared in daily 'Express' Newspaper on 25 December, 2024. The said advertisement is in violation of Punjab Procurement Rules 2014, Rule No. 14 'Response Time'.

In the tender notice, the submission and opening date of bids is given on 02-01-2025, where it does not fulfill the fifteen days of response time, and is six (6) days less. It is a violation of Punjab Procurement Rules 2014, Rule 14. The Rule is quoted below for your reference;

14. Response time.— (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for prequalification) from the date of publication of an advertisement or notice keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

Deputy Commissioner Multan, Kachehri Compound, Multan is requested to rectify the given mistake and issue corrigendum in accordance with Punjab Procurement Rules 2014 to avoid mis-procurement under Rule 69.

Note:

This is to clarify that Transparency International Pakistan is not a complainant, it acts as a whistleblower and operate under Article 19-A, of the Constitution of Pakistan which gives the right to public to know how government is being run by public officers. Article 19-A makes the right to access of information pertaining to a public authority a fundamental right, and a three member bench in case of Mukhtar Ahmad Ali vs the Registrar, Supreme Court of Pakistan, Islamabad, headed by Chief Justice Qazi Faez Isa in the landmark judgment on 16 October 2023, in CP No. 3532/2023, has declared that

"What previously may have been on a need-to-know basis Article 19A of the Constitution has transformed it to a right-to-know, and the Access to information is no longer a discretion granted through occasional benevolence, but is now a fundamental right available with every Pakistani which right may be invoked under Article 19A of the Constitution"

No Tender will be issued after the closing date & time. Bids must be defivered to the address below at or before 1130 Hours January 02, 2025. Late bids shall be rejected. The bids shall be opened on the same date January 02, 2025 at 1200 Hours at the Committee Room of this office in the presence of the Bidders or their authorized representatives who choose to attend. All Bids must be accompanied by a Bid Security of 2% of estimated cost (Within the limit of 5% as per rule 27, PPRA Rules 2014) in the form of CDR/Bank Guarantee/Demand Draft/Pay Order in favor of Deputy Commissioner Multan with the Financial Bid and a copy with technical bid, without this, the offer shall be rejected being non-responsive, for case of Public Holiday next day will be considered as working day.

Deputy Commissioner Multan will not be responsible for any cost or expense incurred by Bidders about the preparation or delivery of Bids.

Note: All assessments and procuring procedure i.e. receiving, opening and awarding etc. shall be governed by the Punjab Procurement Rules-2014. In case of any conflict between Bidding Documents and PPRA Rules 2014, the rules shall prevail.
