**Subject: Violation of Punjab Procurement Rules 2014, Director Procurement, Punjab Education Curriculum Training & Assessment Authority (PECTAA), Lahore's Tender Notice for Procurement of Primers / Jackets / Textbooks for Academic Session 202-27**

Dear Sir,

This is with reference to your tender notice appeared in daily 'Dunya' Newspaper on 11 October, 2025. The said advertisement is in violation of Punjab Procurement Rules 2014, Rule No. 14 'Response Time'.

In the tender notice, the submission and opening date of bid is given on 20-10-2025, where it does not fulfill the fifteen days of response time, and is five (5) days less. It is a violation of Punjab Procurement Rules 2014, Rule 14. The Rule is quoted below for your reference;

*14. Response time.– (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for prequalification) from the date of publication of an advertisement or notice keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.*

Director Procurement, Punjab Education Curriculum Training & Assessment Authority (PECTAA), Lahore is requested to rectify the given mistake and issue corrigendum in accordance with Punjab Procurement Rules 2014 to avoid mis-procurement under Rule 69.

Article 19-A makes the right to access of information pertaining to a public authority a fundamental right, and a three member bench in case of Mukhtar Ahmad Ali vs the Registrar, Supreme Court of Pakistan, Islamabad, headed by Chief Justice Qazi Faez Isa in the landmark judgment on 16 October 2023, in CP No. 3532/2023, has declared that


“What previously may have been on a need-to-know basis Article 19A of the Constitution has transformed it to a right-to-know, and the Access to information is no longer a discretion granted through occasional benevolence, but is now a fundamental right available with every Pakistani which right may be invoked under Article 19A of the Constitution”

Single Stage Two envelopes competitive bidding procedure as per the Punjab Procurement Regulatory Authority (PPRA) Rules, 2014 (Amended) shall be adopted. A Non-Member, as defined under Article 240 of the Constitution of the Islamic Republic of Pakistan, shall not associate or be associated, whether as Lead Bidder, Joint Venture partner, or Bidder in Agreement, with the printing or publication of the Terjuma-ul-Quran-ul-Majeed for Grades VI to X. Bid submission only through EPADS shall be entertained. Any bid submitted through other means shall not be accepted or considered. The interested bidders shall submit online Technical and Financial Bids on the website of EPADS accompanied by bid security as mentioned in the Bidding Document. Bidders are advised to ensure uploading the e-bid on EPADS well before the submission deadline, and not to wait for the last date and time to upload the bid. A copy of Technical Bid in sealed envelope along with paper samples and Bid Security @ 2% of the estimated price in Pak Rupees, as mentioned in the Bidding Document, from any Scheduled Bank of Pakistan, in the form of original Cash Deposit Receipt / Demand Draft / Pay Order in favour of PECTAA shall be submitted physically in the spirit box available at the Committee Room of PECTAA (Office, 131 E-16, Galang-III, Lahore, well before the time and date of submission of e-bids. Late bids shall not be entertained. In case of discrepancy, the documents uploaded on the EPADS shall prevail. At first instance, Technical Bids shall be opened in the presence of the bidder, or authorized representative, who choose to attend, and credentials of all bidders shall be evaluated through physical and documentary inspection to get proper bid technical evaluation criteria mentioned in the Bidding Document. Thereafter, the Financial Bids of technically qualified bidders shall be announced on a notified date, date and venue in the presence of bidders or their authorized representatives, who choose to attend the meeting. The procurement of good quality paper, ink, glue etc. as per approved specifications mentioned in the Bidding Document is the responsibility of the bidder. The rates shall be inclusive of all costs including applicable taxes and supply at the designated Godowns of PECTAA, PMU, PEF, PEIMA and other organizations at Lahore. In case of official holiday on the day of submission, the next day will be considered as the last submission date for physical submission of copy of technical bid, paper samples and original bid security. The bid shall remain valid for a period of 90 days, commencing from the date of opening of the Technical Bid. Detailed terms and conditions, method of procurement and procedure for submission of bids, and other information are available in the Bidding Document. PECTAA shall not be responsible for any cost or expense incurred by bidder in connection with the preparation or submission of bid. Bid submission on EPADS shall be entirely responsibility of the bidder and PECTAA shall not be held responsible for any issue thereof.
