2. I am directed to inform you that, in compliance with the decision dated 17.03.2026 of the Hon'ble Chancellor, IUB, the University has already issued Notification No.94/Estt-II dated 06.04.2026 (Annex-A), a copy whereof was duly conveyed to you. The said decision clearly provides that the matter has been referred to the Syndicate for further proceedings in accordance with the directions contained therein.

3. However, it is observed with great concern that you are continuously making incorrect, misleading and unsubstantiated assertions in your communications. Your claim that the Registrar undertook to initiate PEEDA proceedings against Mr. Waqas Abdullah, Assistant Engineer (Electrical), before the Hon'ble Chancellor on the day of hearing, and that the Hon'ble Chancellor directed initiation of PEEDA inquiry, is factually incorrect and contrary to the record. No such undertaking or direction exists in the decision of the Hon'ble Chancellor.

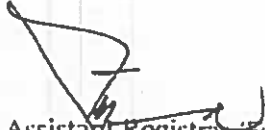

5. Such claims are categorically denied and appear to be an attempt to create unwarranted pressure and agitation, which is inappropriate and unbecoming.

6. The University is proceeding with this matter strictly in accordance with the law, the IUB Act, Statutes, and the directions of the Hon'ble Chancellor. You are, therefore, advised to refrain from making false, baseless and defamatory assertions against the University and its officers, and to await the outcome of the proceedings as directed by the Hon'ble Chancellor, IUB, in his order dated 17.03.2026.

7. I am further directed to inform you that a copy of your communications, along with this response, is being placed before the Office of the Hon'ble Chancellor, IUB for information and appropriate consideration.

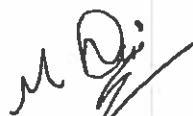

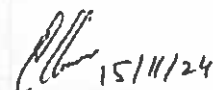
