2. The said tender pertains to **International Competitive Bidding** for the project titled "*Establishment of Primary and Secondary Solid Waste Collection System for District East (Municipal Jurisdiction), Karachi, Pakistan.*"

The decision has been taken in the best interest of transparency, competitiveness, and financial prudence, as the changing market conditions have materially affected the cost structure and feasibility of the project. Accordingly, the tender is hereby cancelled under **Rule-25 of SPPRA Rules, 2010 (amended 2019)**.
