With the approval of Chief Minister, Sindh your revised technical/operational proposal was discussed by the Provincial Cabinet on January 18, 2022. The Cabinet after detailed deliberations has not approved your revised technical / Operational Proposal due to major deviations and contradictions with the Request for Proposal for the Project and the SPPRA Rules, 20210 (Amended 2019).
- 3. Therefore, please note that your Bid for the Project is no longer valid and has terminated, without any further obligation on our part and without prejudice to our accrued rights and liabilities.
- 4. We look forward to collaborating on areas of mutual interest in the future.
