As per the Request for Proposal (RFP) dated 29th September 2021, Annexure B - Technical and Financial Evaluation and Qualification Criteria, 1.3 – Equipment Capabilities, it was required that the Bidder must provide a list of at least 500 vehicles, along with vehicle registration certificates, which had been managed or owned by the Bidder for a minimum period of 5 years, the Bid submitted by Fujian Dong Fei Environment Group Co., Ltd (hereafter referred to as "Bidder") contained a list of 706 Equipment/Machinery. However, after evaluation it was discovered that only 244 vehicles out of 706 met the criteria of being managed for more than 5 years.

- ISO 9001:2000 Quality Management System Certificate,
- OHSAS 18001 certification for occupational health and safety management.
- Membership of ISWA (International Solid Waste Association) /CIWM (Chartered Institution of Solid Waste) / Equivalent





Whereas, the following certificates were found in the Bid:

- ISO 14001:2015 Environment Management System Quality Certificate,
- ISO 9001:2000 Quality Management System Certificate,
- Membership of ISWA (International Solid Waste Association) /CIWM (Chartered Institution of Solid Waste) / Equivalent

The fourth submitted certificate, namely, *GB/T 45001-2020/ISO 45001:2018*, was produced as an equivalent to "*OHSAS 18001 certification for occupational health and safety management*" which did not comply with the criteria set in the RFP. The criteria set was uniform for all the bidders and the only exemption to provide an equivalent was for the certificate of Membership of ISWA (International Solid Waste Association) /CIWM (Chartered Institution of Solid Waste), as clearly stated in the RFP.

As per the RFP dated 29th September 2021, *Annexure B - Technical and Financial Evaluation and Qualification Criteria*, 3.2 - Average Revenue of the last 3 years (USD million) it was requested by the bidder to have a minimum average revenue of USD 40 million to receive 5 marks.

As per the submitted Bid, the two pieces of information w.r.t to the financial information were found. One a summary table of the revenue of each year (which was also presented in the February 4, 2022 letter) and second financial statements of the Bidder. There was an inconsistency in both the pieces of information as the revenue stated in the financial statements did not match the revenue provided in the summary table. The financial statements provided were audited and were therefore evaluated, as per requirement stated in the RFP. Revenues from the financial statements were as follows:

The Bidder stated in its letter that "consolidated reports were delayed on account of Notary Public for Notarization & Embassy Certification purpose". It must be reiterated that no substance change in the bid is allowed, with the exemption of rectifying an arithmetic error, and only the submitted documents were reviewed for the purpose of evaluation and any additional documents submitted would not be considered for evaluation as stated in ITB 21.1 of the RFP, which states:

"To assist in the examination, evaluation and comparison of the Technical Proposals and /or Financial Proposals, the Employer may, at its discretion, ask the Bidders for any clarification, additional information or supporting documentation in respect of any matter associated with the documentation submitted by the Bidders in their Bids. Any such request and the response shall be in writing and no change in the price in the Financial Proposals or substance of the Bid shall be sought, offered or permitted except to confirm the correction of arithmetic errors discovered by the Employer in the evaluation of the Bids, in accordance with ITB 22.4"

Necessary to mention here that, an Independent Third Party i.e. Technical Advisory Team, a consortium of Professionals completed all technical and financial evaluation of all the companies participated in the instant tenders by following the technical criteria clearly set out in the Request for Proposal for the Project. The clarification sought from all the other bidders were on account of clarity, and any additional documents submitted were not considered for marking purposes.
